

For the registration of children born outside of Iceland and have a **guaranteed** right to an Icelandic citizenship. This includes children of parents with an Icelandic citizenship and children adopted from abroad based on an Icelandic adoption permit. If an Icelandic citizen adopts a child in another country based on foreign adoption permits, they can request to have the adoption confirmed by the District Commissioner. Upon confirmation from the District Commissioners office, the child is granted an Icelandic citizenship.

## Instructions

**Submitting:** The form can be delivered in person at Registers Iceland service center, Borgartún 21, 105 Reykjavík or sent by mail. If the child is born in a Nordic country the form can be sent via email. **Note a copy of legal IDs for the parent must always accompany the form.** If delivered in person legal ID must be presented.

**Original:** Supporting documents must be the original copies, photocopies of the documents are not sufficient. Further information regarding document requirement can be found [here](#).

**Third party:** If a third party delivers the form, the mandate above must be filled out and a copy of a legal ID from the holder of the mandate (third party) must be included.
